

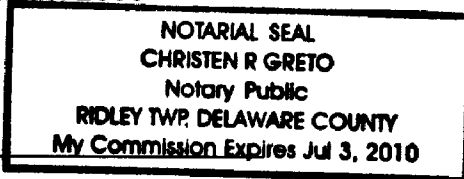
**AFFIDAVIT OF MARK EPSTEIN**
