

Mark Epstein, being duly sworn, states the following:

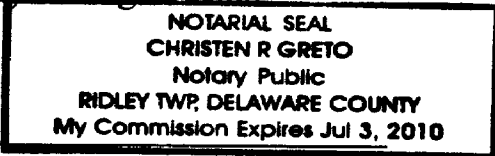
1. I am General Counsel for ATX Communications, Inc. and its subsidiaries and affiliated companies (collectively, "ATX").
