

**AFFIDAVIT OF MARK EPSTEIN**

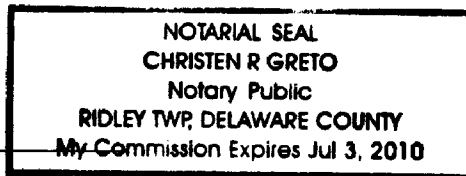
Mark Epstein, being duly sworn, states the following:
