**CONFIRMATORY TRADEMARK ASSIGNMENT  
OF UNITED STATES TRADEMARKS  
AND  
UNITED STATES REGISTRATIONS  
AND PENDING APPLICATIONS FOR REGISTRATION THEREOF**

**As of August 1, 2006**

WHEREAS, HEALTH CARE SERVICE CORPORATION, an Illinois mutual legal reserve corporation ("ASSIGNOR"), acquired, adopted, and used, and thereby owns, all rights, title, and interests in and to the trademarks and United States registrations thereof, and United States applications for registration thereof, identified in Exhibit A attached hereto and by this reference incorporated herein (the "MARKS," "REGISTRATIONS," and "APPLICATIONS," respectively), along with any goodwill associated therewith; and

WHEREAS, pursuant to that certain Contribution Agreement dated the date hereof (the "AGREEMENT") entered into by and between ASSIGNOR, AVAILITY, L.L.C., a limited liability company organized and existing under the laws of the State of Delaware ("ASSIGNEE"), and the other parties thereto, ASSIGNOR has agreed to assign to ASSIGNEE, its entire rights, title, and interests in and to the MARKS, REGISTRATIONS, and APPLICATIONS, along with any goodwill associated therewith (collectively referred to herein as the "ASSIGNED RIGHTS"), whereby ASSIGNEE will be a successor to the portion of the business of ASSIGNOR to which such ASSIGNED RIGHTS pertain, such business being ongoing and existing; and

WHEREAS, in order to effectuate ASSIGNOR's assignment of its entire rights, title and interests in and to the ASSIGNED RIGHTS, and the goodwill associated therewith, to ASSIGNEE, ASSIGNOR is executing this instrument of assignment.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, ASSIGNOR does hereby sell, assign, convey, and transfer to ASSIGNEE, its successors, assigns, and legal representatives, its full and entire rights, title, and interests in and to the ASSIGNED RIGHTS identified in Exhibit A, and (i) the goodwill associated therewith and the portion of the business of ASSIGNOR to which such ASSIGNED RIGHTS pertain, which business is existing and ongoing, (ii) all of ASSIGNOR'S rights to sue for infringement of any of such ASSIGNED RIGHTS, and (iii) any and all renewals and extensions thereof that may hereafter be secured under the laws now or hereafter in effect in the United States, the same to be held and enjoyed by ASSIGNEE, its successors, assigns and legal representatives from and after the date hereof as fully and entirely as the same would have been held and enjoyed by ASSIGNOR has this assignment not been made.

ASSIGNOR hereby agrees that ASSIGNEE shall have the right to record this instrument of assignment in the United States Trademark Office so as to establish ASSIGNEE as owner of record of the ASSIGNED RIGHTS in the United States.

ASSIGNOR further agrees, at the request of ASSIGNEE and without charge or cost to ASSIGNEE (other than reimbursement of out-of-pocket expenses which are reasonably

incurred), to: (i) execute and have executed any and all other documents of any kind whatsoever, and to provide any information that is in ASSIGNOR's possession or under its control that may be reasonably required to carry out the terms and intent of this Assignment; and (ii) fully cooperate with ASSIGNEE, as reasonably required, to enable ASSIGNEE to duly record this instrument of assignment with the United States Patent and Trademark Office so that ASSIGNEE's ownership of the ASSIGNED RIGHTS is duly made of record in the United States.

This Assignment is subject and subordinate to all of the terms and provisions of the Agreement, and in the event of any conflict between any term or provision hereof and any term or provision of the Agreement, the Agreement shall control.
