RELEASE OF SECURITY INTEREST

WHEREAS, Wilson Greatbatch Ltd. ("WGL"), a corporation having an office at 9645 Wehrle Drive, Clarence, New York 14031, has entered into a certain Credit Agreement dated September 8, 1997, with Fleet National Bank ("Fleet Bank"), a banking corporation having an office at One Federal Street, Boston, Massachusetts 02211;

AND WHEREAS, as a condition precedent to entering into the Credit Agreement, Fleet Bank required WGL to execute a Trademark Security Agreement granting to Fleet Bank a security interest in certain Trademark Collateral including the Registered Trademarks of the United States listed in Exhibit A attached hereto and made a part hereof;

AND WHEREAS, Fleet Bank does hereby acknowledge and affirm that all indebtedness and obligations of WGL to Fleet Bank under the financing arrangements of the Credit Agreement have been irrevocably paid in full and that the basis for the Trademark Security Agreement granted to Fleet Bank no longer exists;

NOW, THEREFORE, Fleet Bank does hereby irrevocably terminate to WGL the Trademark Security Agreement and release its security interest to WGL in the Trademark Collateral listed in Exhibit A, the same to be held and enjoyed by WGL for its own use and enjoyment, and for the use of and enjoyment of its successors, assigns and other legal representatives, as fully and entirely as the trademarks would have been held and enjoyed by WGL if the Trademark Security Agreement had not been made.

This Release of Security Agreement is made as of the 17th day of August, 2006.
