GLOBAL TRADEMARK ASSIGNMENT

This GLOBAL TRADEMARK ASSIGNMENT (the "Agreement") is effective as of May 31, 2006 (the "Effective Date"), by and between Chatam International Inc., a Delaware corporation ("Chatam"), and Brown-Forman Corporation, a Delaware corporation ("Buyer").

WITNESSETH:

WHEREAS, Chatam is the owner of certain CHAMBORD trademarks and other Intellectual Property used in connection with alcoholic beverages and other products;

WHEREAS, pursuant to the Asset Purchase Agreement among Chatam, Charles Jacquin et Cie., Inc. ("Charles Jacquin"), the Selling Stockholders and Buyer, dated March 15, 2006 ((the "Purchase Agreement"); capitalized terms used but not defined herein shall have the meanings ascribed therein), Chatam and Charles Jacquin have agreed to sell the Transferred Assets (which include the Transferred Intellectual Property) to Buyer;

WHEREAS, the Transferred Assets include the trademarks, service marks and trade names set forth on Schedule A (the "Marks"), and therefore, this Agreement is a Related Agreement, which is required to be executed on or before the Closing Date, pursuant to Section 6.7 of the Purchase Agreement; and

NOW, THEREFORE, in consideration of the above premises and of the mutual agreements, provisions and covenants contained in this Agreement and intending to be legally bound hereby, Chatam and Buyer hereby agree as follows:

1. Chatam hereby assigns, transfers and conveys to Buyer any and all of Chatam's right, title and interest worldwide in and to the Marks, together with all related common-law rights and the goodwill of the business associated therewith or symbolized thereby.
2. Buyer is to hold all right, title and interest in and to the Marks as fully and exclusively as it would have been held and enjoyed by Chatam had the assignment in Section 1 not been made. Chatam shall not contest Buyer's ownership of the Marks, including in any claim, action, arbitration, suit, inquiry or proceeding.
3. This assignment shall also include, subject to the Purchase Agreement, all claims for damages by reason of past infringement of the Transferred Intellectual Property and the Marks, if any, together with the right to sue for and collect the same for the sole use and benefit of Buyer and its successors, assigns, or other legal representatives.
4. This Agreement shall be deemed effective as between the parties as of the Effective Date.
5. Chatam will, without additional consideration, take such further actions and execute promptly such further documents as are necessary or desirable to transfer, vest, record and perfect good, valid and marketable title to the Marks in Buyer. Chatam hereby authorizes Buyer to request the relevant government entity or agency, in each applicable country or jurisdiction, to record Buyer as the assignee and owner of the Marks.

6. This Agreement may be executed in one or more counterparts, and by the different parties hereto in separate counterparts, each of which when executed shall be deemed to be an original but all of which taken together shall constitute one and the same agreement.

7. This Agreement shall be governed by and construed in accordance with the laws of the State of Delaware (without regard to the principles of conflicts of laws thereof).

IN WITNESS WHEREOF, the parties hereto execute this Agreement as of the date first above written.
