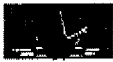

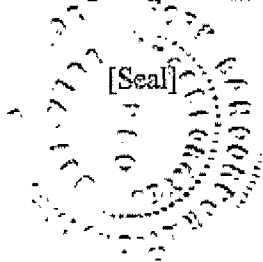


AFFIDAVIT OF MERGER

I, Aurelie S. Campbell, do hereby state and affirm as follows:

1. I am the Vice President & Corporate Secretary of North Fork Bancorporation, Inc., a Delaware Corporation ("North Fork"), and North Fork Bank (the "Bank").
2. North Fork was a party to an Agreement and Plan of Merger dated as of February 15, 2004 (the "Merger Agreement"), by and between North Fork and GreenPoint Financial Corp., a Delaware corporation ("GreenPoint Financial").
3. A Certificate of Merger was filed with the Secretary of State of the State of Delaware on October 1, 2004, pursuant to which GreenPoint Financial was merged with and into North Fork, in accordance with the Merger Agreement, effective as of 6:00 a.m., New York City time, on October 1, 2004.
4. Incident to the merger, GreenPoint Bank became a wholly-owned subsidiary of North Fork.
5. Incident to the merger, all assets of GreenPoint Financial and GreenPoint Bank became assets of North Fork.


