RELEASE OF SECURITY INTERESTS IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this "Release") is dated as of August 31, 2006 by Deutsche Bank AG, acting through its London Branch, in its capacity as Collateral Agent ("Agent") under that certain Security Agreement among Lin Pac, Inc. ("Grantor"), the other assignors from time to time party thereto, and the Agent dated as of October 22, 2003 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement").

WHEREAS, Agent and Grantor entered into that certain Grant of Security Interest in United States Trademarks dated as of October 22, 2003 (the "Agreement");

WHEREAS, the Agreement granted Agent a security interest in, among other things, certain United States trademarks, trademark registrations, designs and trademark applications, including, without limitation, the trademarks listed on Schedule A attached hereto (the "Released Trademarks"), as security for certain obligations of Grantor and the other parties thereto under the Security Agreement (the "Obligations");

WHEREAS, Agent recorded the Agreement on February 10, 2004 at Reel 2913, Frame 0613 in the United States Patent and Trademark Office ("PTO"); and

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby agrees as follows:

Agent hereby fully releases and terminates its security interest in and lien on:

(a) all of Grantor's right, title and interest in and to all Released Trademarks which are now filed with the PTO, any similar office or agency of any state, territory or possession of the United States or Canada or any similar office or agency of any other country, or used in the United States, any state, territory or possession thereof including, without limitation, Puerto Rico, or any other country, and (i) any renewals thereof, (ii) all income, royalties, damages and payments due or payable with respect thereto, including, without limitation, payments under all licenses entered into in connection therewith and damages, and payments for past or future infringements thereof, (iii) the right to sue for past, present and future infringements thereof, (iv) all documents, packages, prints and labels on which said Released Trademarks have appeared and all designs and general intangibles of a like nature, and (v) all rights corresponding thereto throughout the world;

(b) the goodwill of Grantor's business connected with or symbolized by Released Trademarks; and

(c) any claims by Grantor against third parties for infringement of the Released Trademarks or of any license with respect thereto.
