## INTELLECTUAL PROPERTY ASSIGNMENT

This INTELLECTUAL PROPERTY ASSIGNMENT Agreement (the "Agreement") is made on this 15<sup>th</sup> day of May, 2006 (the "Effective Date") by and between AMERICAN INSTITUTE OF CERTIFIED PUBLIC ACCOUNTANTS, a not-for-profit corporation organized under the laws of the District of Columbia, having a place of business at 1211 Avenue of the Americas, New York, New York 10036-8775 ("Assignor"), and XBRL INTERNATIONAL, INC., a not-for-profit corporation organized under the laws of Delaware (and formerly known as "xbrl.org"), having a place of business at 1211 Avenue of the Americas, New York, New York 10036-8775 ("Assignee").

WHEREAS, Assignor is willing to assign certain trademarks and domain names to Assignee pursuant to the terms of this Agreement;

NOW THEREFORE, pursuant to the terms and conditions of this Agreement and for good and valuable consideration, including the provisions and covenants herein, the receipt of which is hereby acknowledged, Assignor and Assignee agree as follows:

1. Assignee agrees to appoint a nominee selected by Assignor, by no later than August 1, 2006, to a seat on the International Steering Committee (ISC) of Assignee for a term of five years.

2. Assignor hereby transfers and assigns to Assignee, its successors and assigns, all of its right, title and interest whatsoever throughout the world in and to: (a) the trademarks and service marks listed in the annexed Schedule A (the "Trademarks") including registrations and applications therefor, all common law rights and all goodwill associated therewith, the right to license others under the Trademarks and the right to renew any trademark registration which shall issue from the applications included in the Trademarks; (b) the registrations for the domain names listed in the annexed Schedule B (the "Domain Names"); (c) all claims for damage by reason of past or future infringement of said Trademarks and Domain Names with the right to sue and collect the same for its own use or for the use of its successors, assigns or other legal representatives; and (d) all rights corresponding to the foregoing.

4. This Agreement shall be interpreted and enforced under the laws of the United States, if required, and the laws of the State of New York, without regard to any choice of laws or conflict of laws rule thereof, except to the extent federal substantive law is required.

5. This Agreement may be executed simultaneously in one or more counterparts, each of which shall be deemed an original, but both of which together shall constitute one and the same instrument.

6. Assignor hereby agrees to execute upon the request of Assignee such additional documents as are necessary to continue, secure, defend, register, and otherwise give full effect to and to perfect the rights of Assignee under this Agreement, including all documents

necessary to register in the name of Assignee the assignment of the Trademarks and Domain Names.
