RELEASE AND REASSIGNMENT OF TRADEMARKS

THIS RELEASE AND REASSIGNMENT dated May 15, 2006 by HARRIS N.A. ("*Harris*"), as successor by merger with Harris Trust and Savings Bank, as agent as hereinafter described, with its main office and mailing address at 111 West Monroe Street, Chicago, Illinois 60603 (Harris acting as such agent hereinafter referred to as the "*Agent*");

WITNESSETH:

WHEREAS, National By-Products, LLC (f/k/a National By-Products, Inc.) (the "*Debtor*") with its mailing address at P.O. (ii) All proceeds of the foregoing, including without limitation any claim by the Debtor against third parties for damages by reason of past, present or future infringement of any trademark, trademark registration or trademark application listed on Schedule A hereto or by reason of injury to the goodwill associated with any such trademark, trademark registration or trademark application, in each case together with the right to sue for and collect said damages.

IN WITNESS WHEREOF, the Agent has caused this Release and Reassignment to be duly executed by its duly authorized officer as of the day and year first above written.

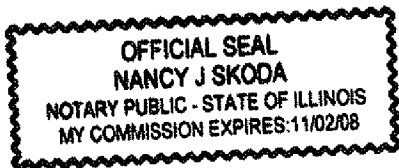
