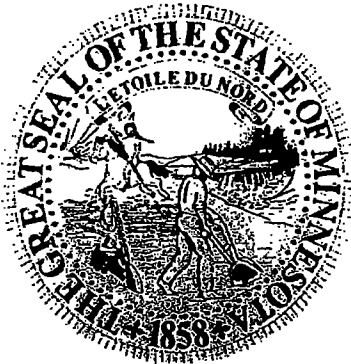

**FIRST:** The name and jurisdiction of formation or organization of each of the constituent entities which is to merge are as follows:


