RELEASE OF SECURITY INTEREST -- TRADEMARKS

WHEREAS, Bank of America, FSB, as Collateral Agent ("BofA") and Law Companies Group, Inc. ("LCG") are parties to a certain Security Agreement dated as of January 15, 1998 (the "Security Agreement"), recorded with the United States Patent and Trademark Office on January 21, 1998, at Reel 1687, Frame 0360, pursuant to which LCG granted to BofA a security interest in the trademark set out in Exhibit A hereto (the "Mark") and provided for the enforcement of such security interest; and

WHEREAS, BofA desires to: (i) release the security interest in the Mark; (ii) waive all of its right, title and interest in such Mark, and restore all such right, title and interest to the Mark to LCG; and (iii) dissolve any and all liens and encumbrances respecting the Mark.
