**RELEASE OF SECURITY INTEREST -- TRADEMARKS**

WHEREAS, Bank of America, FSB, as Collateral Agent ("BofA") and Law Engineering and Environmental Services, Inc. ("LEES") are parties to a certain Security Agreement dated as of January 15, 1998 (the "Security Agreement"), recorded with the United States Patent and Trademark Office on January 21, 1998 at Reel 1688, Frame 0016, pursuant to which LEES granted to BofA a security interest in the trademark set out in Exhibit A hereto (the "Mark") and provided for the enforcement of such security interest; and
