

Assignor further agrees to execute any and all documents and do any further such acts that shall be required in order for Assignee to secure such rights.

AND, the Assignor represents and warrants that it has not previously sold, assigned, conveyed or otherwise disposed of the Rights conveyed hereunder.

AND, the Assignor is assigning said Rights "AS IS-WHERE IS" "WITH ALL FAULTS AND WITHOUT RECOURSE". No representations or warranties are being made by Assignor as to the validity of the Rights, whether they still exist or have expired or been cancelled, or whether they violate or infringe upon the rights of third parties, and Assignor shall have no obligation or liability to Assignee with respect to same.


