**RELEASE OF SECURITY INTEREST**  
**(Trademarks)**

This RELEASE OF SECURITY INTEREST (Trademarks) (this "Release") is made and effective as of the 30<sup>th</sup> day of September 2004 (the "Effective Date") and is granted by **BANK OF AMERICA, NATIONAL ASSOCIATION, a national banking association (formerly known as Nationsbank, N.A. (South) [as Agent] ("Secured Party")**, in favor of **FIREARMS TRAINING SYSTEMS, INC., a Delaware Corporation ("Debtor")**.

WHEREAS, Debtor granted to Secured Party a continuing security interest in all of the Debtor's right, title and interest in, to and under the trademarks and trademark registrations listed on the annexed Schedule A (the "Trademark Collateral"), to secure the payment, performance and observance of the obligations referred to therein;

Upon this reassignment, all right, title and interest in the Trademark Collateral shall be vested in Debtor as fully as if the Assignment had not been made.
