CERTIFICATE OF MERGER

MISYS INTERNATIONAL BANKING SYSTEMS (WHITE PLAINS) INC.

Under Section 904 of the Business Corporation Law

It is hereby certified upon behalf of each of the constituent corporations as follows:

~~FIRST:~~ The Board of Directors and Shareholders of each of the constituent corporations have duly adopted a plan of merger setting forth the terms and conditions of the merger of the corporations.

~~SECOND:~~ The name of the constituent corporation that is to be the surviving corporation, and which is sometimes referred to in this Certificate as the "Surviving Corporation", is Misys International Banking Systems (White Plains) Inc. The name under which it was formed is The Frustum Group, Inc. The date upon which its certificate of incorporation was filed by the Department of State is September 18, 1991.

~~THIRD:~~ The name of the foreign constituent corporation, which is being merged into the Surviving Corporation, and which is sometimes referred to in this Certificate as the "Merged Corporation", is Misys International Banking Systems Inc. The name under which it was formed is Kapiti Americas, Inc. The jurisdiction of its incorporation is Delaware. The date of its incorporation is November 17, 1986.

The application for authority of the Merged Corporation to transact business in the State of New York as a foreign corporation was filed by the Department of State of New York on January 8, 1987.

~~FOURTH:~~ The designation of the only class of the outstanding shares of Misys International Banking Systems (White Plains) Inc. is common stock having no par value. The total number of such shares outstanding is 436. Each share is entitled to one (1) vote.

~~FIFTH:~~ The designation of the only class of the outstanding shares of Misys International Banking Systems Inc. is common stock, par value \$1.00 per share. The total number of such shares outstanding is 330. Each share is entitled to one (1) vote.

~~SIXTH:~~ The following amendment or change in the Certificate of Incorporation of Misys International Banking Systems (White Plains) Inc. is to be effected by this merger:

Article 6 (one) of the Certificate of Incorporation which sets forth the name of the corporation is hereby amended to read as follows:

"(1) The name of the corporation is Misys International Banking Systems Inc."

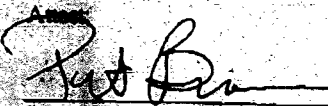
The aforesaid change of corporate name of the surviving corporation has been duly approved by the State of New York Banking Department on April 25, 2003. This consent of the Banking Department is annexed hereto.

SEVENTH: The effective date of the merger of Misys International Banking Systems Inc. into Misys International Banking Systems (White Plains) Inc. together with the resulting change of name of the Surviving Corporation, as aforesaid, shall be May 31, 2003.


EIGHTH: (a) The merger of Misys International Banking Systems Inc. and Misys International Banking Systems (White Plains) Inc., was authorized in respect to Misys International Banking Systems (White Plains) Inc., a constituent corporation, by the resolution of the Board of Directors in a Unanimous Written Consent and the resolution by Written Consent of the Sole Shareholder.

(b) The merger herein certified was authorized in respect of the merged constituent corporation in accordance with the laws of its jurisdiction of incorporation and is in compliance with said laws.

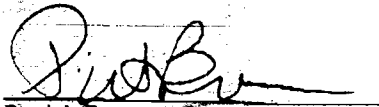
