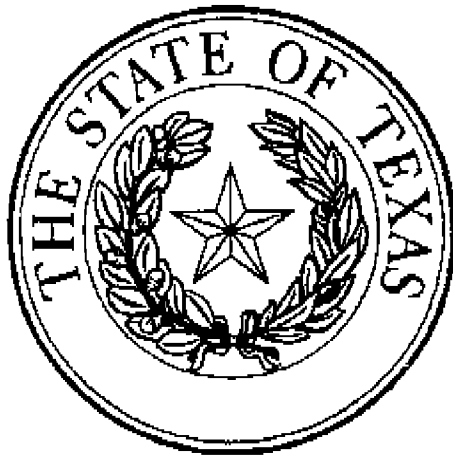

II.


The Certificate of Limited Partnership of the Partnership is hereby amended by deleting existing Article 1 thereof in its entirety and replacing it with the following new Article 1:
