TRADEMARK ASSIGNMENT

This Assignment Agreement is by and between HERE & THERE, LLC, a limited liability company organized and existing under the laws of New York having a place of business at 104 West 40th Street, New York, New York 10018 (“Assignor”) and HENRY DONEGER ASSOCIATES, LLC, a corporation organized and existing under the laws of New York, with an address at 463 Seventh Avenue, New York, New York 10018 (“Assignee”).

In consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor assigns to Assignee, all of Assignor’s right, title, and interest in and to the Marks, including all Applications and Registrations and all common law rights, together with the business, or portion thereof, to which the Marks pertain, the goodwill symbolized by use of the

Marks, and the right to sue third parties for and recover damages from past and future infringement of the Marks.

All covenants and obligations herein shall be binding on and inure to the benefit of Assignor, Assignee and their respective successors and permitted assigns.

Assignor hereby authorizes the Commissioner of Patents and Trademarks of the United States, and any official of any other country empowered to issue trademark registrations, to record this Assignment, and to issue or transfer all said Applications and/or Registrations to Assignee as owner of all right, title and interest therein, or otherwise as Assignee may direct, in accordance with the terms of this Assignment.




