RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE (TRADEMARK) is given as of September 8th, 2006, to Stock Equipment Company, Inc. (formerly Stock Equipment Acquisition, Inc.), a Delaware corporation (“**Borrower**”), Stock Equipment Holdings, Inc., a Delaware corporation (“**Parent**”, together with Borrower collectively the “**Pledgor**”) with their principal place of business at 16490 Chillicothe Road, Chagrin Falls, OH 44023, by LaSalle Bank National Association, a national banking association, with its principal place of business at 135 South LaSalle Street, Chicago, Illinois 60603 (“**Bank**”).

WHEREAS, Pledgor and Bank entered into a Trademark Security Agreement, dated as of October 23, 2003 (the "Security Agreement"), which was recorded in the United States Patent and Trademark Office on November 5, 2003 at Reel 2856, Frame 0680, pursuant to which Borrower granted to Bank, by way of a first mortgage and security interest, a security interest having priority over all other security interests, to all of Borrower's right, title and interest in and to the Trademarks and Licenses (as defined in the Security Agreement) referred to in Schedule A and B thereto, and identified in Schedule A and B to this Release, and all good will associated with the Trademarks and Licenses; and,

WHEREAS, Borrower has promptly paid and performed all its Secured Obligations (as defined in the Security Agreement), and Bank desires to release its security interests in and liens upon the Trademarks and Licenses.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Bank hereby releases its lien on and security interest in all Borrower's right, title and interest in and to the Trademarks and Licenses and reassigns any and all interest it may have in such Trademarks and Licenses to Borrower.
