NOTICE OF TRADEMARK SECURITY AGREEMENT
(FOR RECORDATION PURPOSES)

This Notice of Trademark Security Agreement, dated as of September ____, 2006, is made by and between CRAFTIQUE, LLC, a North Carolina limited liability company, whose address and principal place of business is 1257 W. 


