**ASSIGNOR** further covenants that Assignee will, upon its request, be provided promptly with all pertinent facts and documents relating to said Marks, will assist in the preparation and filing of all legal documents relating thereto, will testify as to the same in any interference, opposition or proceeding related thereto, and will promptly execute and deliver to Assignee or its legal representatives any and all papers, instruments or




affidavits required to apply for, obtain, issue and enforce any such Marks which may be necessary or desirable to carry out the purposes thereof.
