Releasor covenants that it will at any time and at the request of Owner execute such documents and take such other action that in the opinion of Owner may be desirable or necessary to secure to Owner, its successors, legal representatives and assigns, all rights intended to be released, quitclaimed and assigned by this instrument. Releasor further covenants that it will take no action in the future that will prejudice Owner's rights in and to the Mark(s), but Releasor otherwise does not by this Instrument warrant that it now has any such rights or title in or to the Mark(s).

This Release, Quitclaim and Assignment shall be binding on Releasor and Releasor successors, legal representatives and assigns.
