Quantum Orthopedics Inc. (the "*Company*"), a corporation organized and existing under the Delaware General Corporation Law (the "*DGCL*"), does hereby certify:

FIRST: The original name of the Company is Quantum Orthopedics Inc. and the date of filing the original Certificate of Incorporation of the Company with the Secretary of State of the State of Delaware was August 16, 2004.

SECOND: The date on which the Amended and Restated Certificate of Incorporation of the Company was filed with the Secretary of State of the State of Delaware was August 30, 2004.

THIRD: The date on which the Certificate of Amendment of the Amended and Restated Certificate of Incorporation of the Company was filed with the Secretary of State of the State of Delaware was February 22, 2006.

Article I. shall be amended and restated to read in its entirety as follows:


"The name of this company is Spinal Elements, Inc. (the "*Company*" or the "*Corporation*")."

FIFTH: Thereafter, pursuant to a resolution of the Board, this Second Certificate of Amendment of Amended and Restated Certificate of Incorporation of the Company was submitted to the stockholders of the Company for their approval, and was duly adopted and approved in accordance with the provisions of Sections 228 and 242 of the DGCL.

SIXTH: All other provisions of the Amended and Restated Certificate of Incorporation, as amended, as currently on file with the Secretary of State of the State of Delaware, shall remain in full force and effect.
