DECLARATION OF MARK KOHLER


1. I, Mark Kohler, make this declaration in support of Registrant's Combined Declaration of Use & Incontestability.
2. I am Chief Financial Officer, Secretary and Treasurer of Registrant, AirIQ Marine, Inc.
3. As evidenced by the public auction receipt issued by Fischer Auction Company, Inc., a copy of which is attached hereto as Exhibit 1, on August 25, 2003, HPLX Funding, LLC purchased all assets of Advanced Remote Communication Solutions, Inc. ("ARCSI") at a public auction. The assets purchased included all right, title and interest in and to all intangible property owned by ARCSI, including, without limitation, all trademarks, trademark registrations and applications, and all goodwill of ARCSI. A copy of Exhibit 1 is being filed simultaneously with the Assignment Division of the U.S. Patent and Trademark Office ("PTO"). Among the trademarks assigned to HPLX Funding, LLC were BOATCOMM (Reg. No. 2,263,381) and BOATRACS (Reg. Nos. 2,341,173 and 2,408,052).

4. On October 5, 2004, HPLX Funding, LLC assigned the BOATRCOMM and BOATRACS registrations to Boatracs, LLC, a Delaware limited liability company. The assignment was recorded in the Assignment Division of the U.S. Patent and Trademark Office ("PTO") at Reel/Frame 2952/0293.

5. On October 7, 2004, Boatracs, LLC changed its name to HPLX-B, LLC, a Delaware limited liability company. The change of name was recorded in the PTO's Assignment Division at Reel/Frame 3090/0579.

6. On October 14, 2004, HPLX-B, LLC assigned the BOATRCOMM and BOATRACS trademark registrations to AirIQ Marine, Inc. A copy of the assignment document was recorded in the PTO's Assignment Division at Reel/Frame 3094/0084.

7. I declare that all statements made of my own knowledge are true and that all statements made in paragraphs 3 through 6 are made on information and belief and are believed to be true.
