Assignment of Trademarks

The parties acknowledge that Assignee is acquiring the entire business of the Assignor to which the Trademarks pertain.

Assignor agrees to execute and deliver at the request of the Assignee, without further compensation but subject to reimbursement for out-of-pocket expenses, all papers, instruments, and assignments, and to perform any other reasonable acts the Assignee may require in order to vest all Assignor's rights, title, and interest in and to said Trademarks in the Assignee and/or to provide evidence to support any of the foregoing in the event such evidence is deemed necessary by the Assignee, to the extent such execution of any forms, statements or other documents required by any trademark office relating to the Trademarks listed in Schedule A.
