**ASSIGNMENT AND GRANT OF SECURITY INTEREST  
IN PATENTS AND TRADEMARKS**

**WHEREAS**, pursuant to an Assignment, Acceptance and Payoff Agreement (the "Assignment Agreement"), dated as of July 14, 2006, Dymas has resigned as agent under the Security Agreement and Allied Capital Corporation, with offices at 401 North Michigan Avenue, Suite 3310, Chicago, Illinois, 60611, has agreed to act as successor agent (in such capacity, the "Agent");

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, as security for the payment and performance of the Secured Obligations (as defined in the Security Agreement), the Pledgors do hereby assign and grant to the Agent a security interest in all of their right, title and interest in and to the Trademarks and the Patents, and the use thereof, together with all proceeds and products thereof and the goodwill of the businesses symbolized by the Trademarks and the Patents. This Assignment has been given in conjunction with the assignment and security interest granted to the Agent under the Security Agreement, and the provisions of this Assignment are without prejudice to and in addition to the provisions of the Security Agreement, which are incorporated herein by this reference.



