THIS ASSIGNMENT is dated *20<sup>th</sup> May* 2005

**BETWEEN:**

- (1) **HEATH LAMBERT LIMITED** a company incorporated under the laws of England and Wales (Registered Number 01199129) and whose registered office is Friary Court, Crutched Friars, London, EC3N 2NP (the "Assignor"); and
- (2) **HLA GLOBAL (GUERNSEY) LIMITED** a Guernsey limited company whose registered office is at St. Peter Port House, Union Street, St. Peter Port, Guernsey, Channel Islands (the "Assignee").

**WHEREAS:**

- (A) The Assignor is the registered proprietor of the registered trade marks and/or applications, of which short particulars are set out in the Schedule hereto (the "Trade Marks");
- (B) pursuant to a shareholders' agreement entered into on or about the date of this Agreement the Assignee is being operated as a joint venture company between Acordia Inc and the Assignor; and
- (C) the Assignor has agreed to assign the Trade Marks to the Assignee upon the terms and conditions set out below.

**NOW IT IS HEREBY AGREED** as follows:

**1 Assignment**

- 1.1 In consideration of the payment by the Assignee to the Assignor of £1 (receipt of which is hereby acknowledged), the Assignor HEREBY ASSIGNS with full title guarantee to the Assignee absolutely all its rights, title and interest in and to the Trade Marks.
- 1.2 This Assignment shall include all rights of action arising or accrued in relation to the Trade Marks (or any of them), including, without limitation the right for the Assignee to bring proceedings and to seek and recover damages and all other remedies for all past infringement of such rights against any third party (including but not limited to proceedings against any third party for infringement of the Trade Marks (or any of them) or for passing off or for otherwise infringing the rights in the Trade Marks (or any of them) whether taking place before or after the date of this Assignment). The Assignor agrees and undertakes to provide to the Assignee (at its request) all such assistance with any proceedings which may be brought by or against the Assignee against or by any third party in relation to the Trade Marks (or any of them) and the Assignee shall pay the legal costs actually incurred by the Assignor in providing the Assignee with such assistance.

**2 Assignor's Obligations**

- 2.1 The Assignor shall at the Assignee's cost and expense execute all such documents and render all such assistance as the Assignee may reasonably request from time to time for the purpose of giving to the Assignee the full benefit of all the provisions of this Assignment including perfecting the Assignee's title to the Trade Marks (or any of them) including without limitation making applications to register the Assignee as the proprietor of the Trade Marks (or any of them).
- 2.2 The Assignor shall provide to the Assignee upon execution of this Assignment all documentation currently held by or on behalf of the Assignor that relates to the Trade Marks.


### **3 Governing Law**

- 3.1 This Assignment shall be governed by and construed in accordance with English law and the parties irrevocably agree that the courts of England are to have exclusive jurisdiction over any disputes which arise out of or in connection with this Assignment.


