ASSIGNMENT

WHEREAS, Graphic Enterprises, Inc. an Ohio corporation, doing business at 3874 Highland Park NW, North Canton, Ohio 44720, (hereinafter referred to as ASSIGNOR), owns full and exclusive right, title and interest to the trademarks on the attached Schedule A (hereinafter referred to as THE TRADEMARK RIGHTS);

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, ASSIGNOR hereby sells, assigns, transfers and sets over unto the said ASSIGNEE, its successors and assigns, the full and exclusive right, title and interest to THE TRADEMARK RIGHTS and to all Registration Certificates or applications or similar legal protection, not only in the United States and its territorial possessions, but in all countries foreign thereto to be obtained for THE TRADEMARK RIGHTS; and ASSIGNOR hereby authorizes and requests the United States Commissioner of Patents and Trademarks and any officials of foreign countries whose duty it is to issue trademarks as aforesaid, to issue all trademark registrations for THE TRADEMARK RIGHTS to ASSIGNEE in accordance with the terms of this ASSIGNMENT and hereby transfers all rights of action, power and benefit belonging to or accruing from THE TRADEMARK RIGHTS including the right to undertake proceedings to recover past and future damages and claim all other relief in respect of any acts of infringement thereof whether such acts shall have been committed before or after the date of this assignment.


ASSIGNOR hereby covenants that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this Agreement;

ASSIGNOR further covenants that ASSIGNEE will, upon its request, be provided promptly with all pertinent facts and documents relating to THE TRADEMARK RIGHTS and legal equivalents as may be known and accessible to ASSIGNORS and that ASSIGNOR will testify as to the same in any interference or litigation related thereto and will promptly execute and deliver to ASSIGNEE or its legal representative any and all papers, instruments or affidavits required to apply for, obtain, maintain, issue and enforce THE TRADEMARK RIGHTS and said equivalents in the United States or in any foreign country, which may be necessary or desirable to carry out the purposes thereof.
