**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS is given as of this 25 day of SEP., 2006, by BANC OF AMERICA LEASING & CAPITAL, LLC ("Assignor") as successor to FLEET CAPITAL CORPORATION, as successor by reason of merger with SHAWMUT CAPITAL CORPORATION ("Shawmut") which previously purchased substantially all of the assets of BARCLAYS BUSINESS CREDIT, INC. ("Barclays"), in its capacity as Assignor in favor of THINGS REMEMBERED, INC., a Delaware corporation, ("Assignee").

**WHEREAS**, Assignee granted Barclays a security interest in certain collateral pursuant to a Loan and Security Agreement, dated as of September 30, 1993, by and between Assignee, Barclays, and others, and a Grant of Security Interest, dated as of September 30, 1993, by and between Assignee and Barclays, which was recorded with the U.S. Patent and Trademark Office on October 18, 1993, at Reel 1046 / Frame 0461 (the "Security Agreement");

**WHEREAS**, Barclays assigned all of its right, title and interest in and to the Security Agreement to Shawmut pursuant to an Assignment of Security Interest in Trademarks, dated as of January 31, 1995, which was recorded with the U.S. Patent and Trademark Office on February 1, 1995 at Reel 1289 / Frame 0287 (the "Assignment");

**WHEREAS**, Assignor is the successor in interest to Shawmut;

**WHEREAS**, as security for the prompt payment, performance and observance of the Obligations, as defined in the Security Agreement, Assignee granted to Assignor a security interest in all right, title and interest of Assignee in and to the Trademarks, as defined in the Security Agreement, listed on Schedule A hereto, together with the goodwill of the business symbolized by the Trademarks and the customer lists and records related to the Trademarks and the applications and registrations thereof, and all proceeds thereof, including without limitation, any and all causes of action which may exist by reason of infringement thereof (the "Collateral");

**WHEREAS**, Assignor desires to release its security interest in the Collateral.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby releases its security interest and lien in the Collateral and reassigns any and all interest that it may have therein to Assignee.

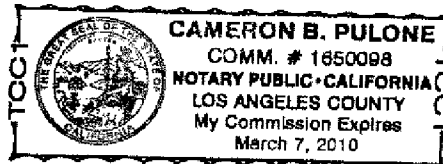
