REDOMESTICATION AND CERTIFICATE OF AUTHORITY

General remarks and official action taken:

On this day came on for consideration by the Commissioner of Insurance, the application of FAMILY LIFE INSURANCE COMPANY, Seattle, Washington, to redomesticate and to amend its Certificate of Authority to change its home office from Seattle, Washington to Austin, Texas.


Pursuant to TEX. INS. CODE ANN. §983.051 and §983.057 evidence has been submitted that FAMILY LIFE INSURANCE COMPANY has amended its Certificate of Incorporation by restatement and changed the home office of the Company from Seattle, Washington to Austin, Texas. The Office of Insurance Commissioner of the State of Washington has approved such redomestication.

THEREFORE, based upon the representations made by FAMILY LIFE INSURANCE COMPANY and upon recommendation by staff, the Commissioner of Insurance finds that the redomestication of FAMILY LIFE INSURANCE COMPANY should be, and is hereby approved.


Further, it is ORDERED that the Certificate of Authority No. 1100, dated July 18, 1960 and Certificate of Authority No. 6906, dated August 19, 1981, issued to FAMILY LIFE INSURANCE COMPANY, Seattle, Washington, be, and the same are hereby canceled and that an amended Certificate of Authority be issued to FAMILY LIFE INSURANCE COMPANY, Austin, Texas.
