**RELEASE AND REASSIGNMENT OF TRADEMARKS**

THIS RELEASE AND REASSIGNMENT dated September 29, 2006 by Bank of Montreal;

**WITNESSETH:**

WHEREAS, Bank of Montreal, a chartered bank of Canada with its mailing address at 115 South LaSalle Street, Chicago, Illinois 60603 (the "*Secured Party*"), and NovaDent Inc., a Delaware corporation with its mailing address at 640 Northwest Gilman Blvd., Issaquah, Washington 98027 (the "*Debtor*") are parties to a certain Trademark Collateral Agreement dated August 31, 2006 which was recorded in the United States Patent and Trademark Office on August 31, 2006 at Reel 003381, Frame 0929, pursuant to which the Debtor granted a security interest in and collateral assignment of certain trademarks, trademark registrations and trademark applications listed on Schedule A attached hereto and certain other property (collectively, the "*Trademarks*"); and

WHEREAS, the Debtor has requested that the Secured Party release its security interests in the Trademarks and reassign the same to the Debtor;

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:


The Secured Party hereby releases its security interests in and collateral assignment of, and reassigns, grants and conveys to the Debtor, without any representation, warranty, recourse or undertaking by the Secured Party, all of its right, title and interest, if any, in and to:

(i) Each trademark, trademark registration and trademark application listed on Schedule A hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each such trademark, trademark registration and trademark application; and

(ii) All proceeds of the foregoing, including without limitation any claim by Debtor against third parties for damages by reason of past, present or future infringement of any trademark or trademark registration listed on Schedule A hereto or by reason of injury to the goodwill associated with any such trademark or trademark registration, in each case together with the right to sue for and collect said damages.
