**TERMINATION OF  
GRANT OF TRANCHE B TRADEMARK SECURITY INTEREST**

This Termination of Grant of Tranche B Trademark Security Interest (this "Termination"), dated as of September 13, 2006, is executed by Laminar Direct Capital, L.P. ("Secured Party") in favor of The Legacy Estate Group LLC, a California limited liability company (the "Company").

**RECITALS**

WHEREAS, Company and Secured Party entered in a certain Tranche B Credit Agreement, dated as of March 15, 2005 (the "Credit Agreement"); and

WHEREAS, in connection with the Credit Agreement, Company entered into a certain Grant of Tranche B Trademark Security Interest dated as of March 15, 2005 (the "Grant"); and

WHEREAS, pursuant to the Grant, Company granted to Secured Party a security interest in certain "Collateral" including certain trademarks; and

WHEREAS, the Credit Agreement and the Grant have been terminated.

NOW, THEREFORE, Secured Party agrees as follows:

1. Secured Party is executing and delivering this Termination as further evidence of the termination of the Grant.

2. Secured Party claims no right, title or interest whatsoever in or to any of the "Collateral" described in the Grant, and, accordingly, Secured Party expressly terminates its security interest in the trademarks listed on Exhibit A hereto, which security interest was evidenced by the recordation of the Grant with the United States Patent and Trademark Office.
