NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, HC&CC does hereby assign, set over and transfer to Switzer Candy Co., its successors and assigns, any and all worldwide right, title and interest in and to the Trademark, together with the goodwill of the business symbolized thereby, and the registrations therefor, and any and all other Intellectual Property, together with the goodwill of the business symbolized thereby.
