THE PROVISIONS OF THIS AGREEMENT AND THE NOTE OBLIGATIONS REFERRED TO HEREIN ARE SUBORDINATE IN THE MANNER AND TO THE EXTENT SET FORTH IN THAT CERTAIN SUBORDINATION AND INTERCREDITOR AGREEMENT (AS AMENDED, THE "INTERCREDITOR AGREEMENT") DATED AS OF THE DATE HEREOF AMONG PNC BANK, NATIONAL ASSOCIATION, INDIVIDUALLY AND AS AGENT TO THE SENIOR LENDERS (AS DEFINED IN THE INTERCREDITOR AGREEMENT), SANKATY CREDIT OPPORTUNITIES, L.P., SANKATY HIGH YIELD PARTNERS II, L.P., SANKATY HIGH YIELD PARTNERS III, L.P. AND RGIP, LLC AND THEIR SUCCESSORS AND ASSIGNS, AS THE SUBORDINATED PARTIES (AS DEFINED IN THE INTERCREDITOR AGREEMENT), SANKATY ADVISORS, LLC, THE COLLATERAL AGENT UNDER THE NOTE PURCHASE AGREEMENT (AS DEFINED IN THE INTERCREDITOR AGREEMENT), ECE HOLDINGS, INC., STREAM INTERNATIONAL INC. AND STREAM NEW YORK INC., AS BORROWERS, AND CALL CENTER HOLDINGS, INC., AS GUARANTOR. EACH HOLDER OF THE NOTE OBLIGATIONS REFERRED TO BELOW, BY ITS ACCEPTANCE THEREOF, SHALL BE BOUND BY THE PROVISIONS OF THE INTERCREDITOR AGREEMENT.

TRADEMARK ACKNOWLEDGEMENT OF SECURITY

WHEREAS, Stream International Inc., a corporation formed under the laws of Delaware, located at 85 Dan Road, Canton Massachusetts 02021 ("Borrower"), owns the marks shown in the attached Schedule A (the "Marks"), for which there are registrations or applications in the United States Patent and Trademark Office under the numbers shown in the attached Schedule A; and

WHEREAS, Borrower is obligated to various financial institutions (collectively, "Purchasers") and Sankaty Advisors, LLC, as agent for Purchasers ("Agent"), pursuant to (i) a certain Note Purchase Agreement, dated the date hereof, among Agent, Purchasers, Borrower and the other parties named therein and (ii) a certain Trademark Collateral Security Agreement, dated the date hereof, made by Borrower in favor of Agent (as each may be amended, modified, restated or supplemented from time to time, collectively, the "Agreements"); and

WHEREAS, pursuant to the Agreements, Borrower is granting to Agent for its benefit and for the ratable benefit of Purchasers a security interest in the Marks, the goodwill of the business symbolized by the Marks, and the registrations and applications therefor.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Borrower does hereby assign and grant to Agent for its benefit and for the ratable benefit of Purchasers a security interest in and to the Marks, together with the goodwill of the business symbolized by the Marks, and registrations and applications therefor, which assignment of security interest shall secure all the Note Obligations as defined in the Agreements and in accordance with the terms and provisions thereof.


