## SECURITY AGREEMENT SUMMARY

This Security Agreement Summary, dated as of October 2, 2006, is made jointly and severally by Readymade, LLC, a Colorado limited liability company, and Walltext, Inc., a California corporation (collectively, the "Debtors"), in favor of Meredith Corporation, an Iowa corporation (the "Lender").

### Background:

Lender has made a loan to the Debtors, which loan is now evidenced by a Promissory Note dated this same date (the "Note"). It is a condition to the obligation to the Lender to grant the loan in accordance with the provisions of Note that the Debtors shall have executed and delivered a Security Agreement-General Form dated this same date (the "Security Agreement") to the Lender for the purpose of granting Lender a security interest in certain assets, including the interests of the Debtors in the trademarks described in Exhibit A-1 attached thereto (the "Trademarks"). This Security Agreement Summary shall set forth the material terms of the Security Agreement related to the Trademarks solely for purpose of providing notice of the Security Agreement with the United States Patent and Trademark Office.

NOW, THEREFORE, in consideration of the premises and for other good and valuable consideration the receipt of which is hereby acknowledged by the Debtors, the Debtors hereby agree as follows:

1. Grant of Security Interest. As collateral security for the prompt and complete payment and performance when due (whether at stated maturity, by acceleration or otherwise) of all indebtedness evidenced by the Note, the Debtors hereby grant to the Lender a security interest in the Trademarks described in Exhibit A-1 attached hereto.
2. Governing Law. This Security Agreement Summary shall be governed by the internal laws of the State of Iowa, except to the extent that the validity or perfection of the security interest granted hereunder, or the remedies hereunder, must be governed by the laws of a jurisdiction other than the State of Iowa.



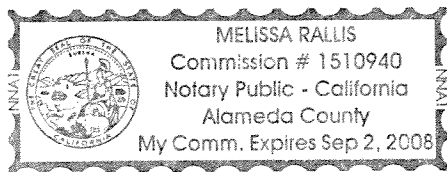

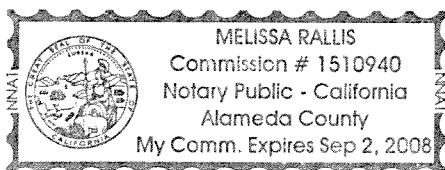
