TRADEMARK ASSIGNMENT

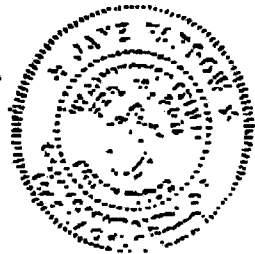
