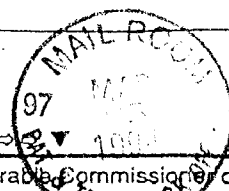

CAPITAL CONTRIBUTION AND ASSIGNMENT AGREEMENT

This Capital Contribution and Assignment Agreement (this "Agreement") between Brown Jordan Company, a North Carolina corporation ("BJC"), and Cherry Grove, Inc., a Delaware corporation ("CGI"), is made pursuant to §351 of the Internal Revenue Code of 1986, as amended, and is to be effective as of the 28th day of December, 1993.

BACKGROUND

CGI was incorporated under the laws of the State of Delaware on December 27, 1993, and as of the effective date of this Agreement, has not issued any shares of its capital stock. CGI has been formed as an investment management and holding company that is to meet the requirements for exemption from Delaware state corporate income tax imposed by §1902(b)(8) of Title 30 of the Delaware Code.

Pursuant to the terms and conditions set forth below, BJC and CGI desire to enter into a transaction in which BJC contributes to CGI (i) capital in an amount to be agreed to between the parties, but in no case shall be less than One Dollar (\$1.00) ("Capital"), (ii) all right, title and interest in those certain trade names, trademarks and service marks, together with all registrations and applications for registration therefor, all as more particularly identified on Exhibit A, which is attached hereto and made a part hereof (collectively, the "Marks"), (iii) all right, title and interest in those certain patents and applications for patents, all as more particularly identified on Exhibit B, which is attached hereto and made a part hereof (collectively, the "Patents"), and (iv) all right title and interest in those certain foreign design registrations and applications for foreign design registrations, all as more particularly identified on Exhibit C, which is attached hereto and made a part hereof (collectively, the "Designs") (the Capital, the Marks, the Patents and the Designs shall be referred to collectively hereinafter as the "Capital Contribution") in exchange for ten (10) Shares of the issued and then outstanding stock of CGI.

AGREEMENT

NOW THEREFORE, in consideration of the above premises and the promises contained in this Agreement, and intending to be legally bound, the parties to this Agreement agree as follows:

§1. Contribution and Assignment of Capital Contribution to CGI.

BJC agrees to assign to CGI all of BJC's right, title and interest in and to the Capital Contribution, such assignment to be effective December 28, 1993.

§2. Issuance of Stock to BJC.

In exchange for and upon the completion of the assignment described in §1 above, CGI is to issue to BJC ten (10) fully paid and non-assessable shares of CGI One Cent (\$.01) par value common stock. At the time of issuance of such shares to BJC, CGI is to be authorized to issue only one class of stock.

§3. Agreement as to Valuation of the Capital Contribution.

BJC and CGI expressly agree that the value of the Capital Contribution is equal to the value of the ten (10) shares of CGI stock to be issued to BJC.

§4. Covenant of CGI.

CGI hereby covenants to determine any amount of the Capital Contribution in excess of the par value of the common stock issued to BJC to be surplus, and not capital, of CGI.

§5. Agreement of CGI and BJC.

CGI and BJC each agree that the Capital Contribution is not being transferred by BJC to CGI in consideration for goods or services rendered.

§6. Appointment of CGI as Attorney of BJC with Respect to the Capital Contribution.

BJC hereby appoints CGI as BJC's true and lawful attorney, with full power of substitution, for BJC, in the name or stead of BJC or otherwise, but on behalf and for the benefit of CGI, to demand and receive all right, title and interest in and to the Capital Contribution hereunder transferred to CGI, or intended so to be; to give receipts, releases and acquittances for or in respect of the Capital Contribution or any part thereof; to collect, assert or enforce any claim, title, right, debt, or account hereby granted or transferred, or intended so to be, and to endorse with the name of BJC any checks received in respect of the foregoing; to institute (or cause to be instituted) and prosecute (or cause to be prosecuted) in the name of BJC, but on behalf and for the benefit of CGI (or its delegate), any proceeding at law or in equity, or otherwise, that CGI may deem proper with respect to the Capital Contribution; and to defend and compromise any and all actions, suits or proceedings in respect of the Capital Contribution that CGI may deem advisable.

§7. Warranties of CGI.

§7.1 CGI is a duly organized and validly existing corporation under the laws of the State of Delaware.

§7.2 CGI (i) is in good corporate standing in the State of Delaware, (ii) operates in no other states, and (iii) has no federal, state or local tax liabilities, which are past due.

§7.3 To the best of the knowledge of the undersigned officer of CGI, there is no legal action or proceeding pending against CGI, which would inhibit the transaction of CGI's ordinary business or prevent CGI from validly entering into this Agreement.

§7.4 CGI has the corporate power to enter into this Agreement and the officer executing this Agreement on behalf of CGI has been duly authorized to do so.

§8. Warranties of BJC.

§8.1 BJC is a duly organized and validly existing corporation under the laws of North Carolina.

§8.2 BJC (i) is in good corporate standing in North Carolina and in every other jurisdiction where its ownership, lease or operation of property or the conduct of its business requires qualification as a foreign corporation except to the extent that the failure to so qualify as a foreign corporation would not have a material adverse effect on BJC, and (ii) has no material foreign national, provincial or local, nor any U.S. federal, state or local tax liabilities, which are past due.

§8.3 To the best knowledge of the undersigned representative of BJC there is no legal action or proceeding pending against BJC which would inhibit the transaction of BJC's ordinary business or prevent BJC from validly entering into this Agreement.

§8.4 BJC has the corporate power to enter into this Agreement and the undersigned representative executing this Agreement on behalf of BJC has been duly authorized to do so.

§9. Mutuality of Consent.

CGI and BJC each acknowledge that this Agreement, and each agreement made in connection with this Agreement, if any, is the manifestation of direct negotiation and each agreement represents the mutual and voluntary consent and understanding of the parties hereto.

§10. Each Party Familiar with Operations of Other Party.

Each party to this Agreement acknowledges that it (i) is familiar with the operations of the other party, (ii) has been provided access to all necessary financial records, statements, accounts or other materials of the other party, which such party

requested, and (iii) is competent to evaluate the risks associated with the performance of its obligations under this Agreement.

§11. Execution and Delivery of Other Documents.

Each party to this Agreement hereby covenants to perform all acts necessary or proper to effectuate the intent and purposes of this Agreement, including the execution and delivery of all other required documentation, if any.

§12. Governing Law.

This Agreement is to be governed by and interpreted and enforced in accordance with Delaware law without reference to the conflict of laws provisions thereof.

§13. Non-assignability.

This Agreement shall be binding upon and inure to the benefit of the parties and their respective successors and assigns; provided, however, that this Agreement, or any portion thereof, may not be assigned without the written consent of the non-assigning party, which consent shall not be unreasonably withheld.

§14. Severability.

If any provision of this Agreement is determined to be invalid or unenforceable, such invalidity or unenforceability shall not affect the remaining provisions of this Agreement.

§15. Entire Agreement.

This Agreement constitutes the entire understanding of the parties with respect to the subject matter hereof and supersedes all prior contracts, understandings and agreements between the parties.

§16. Amendment.

This Agreement may not be amended or modified without the written consent of each party hereto.

§17. Expenses.

Each party agrees to pay its respective expenses incurred with respect to this Agreement and the consummation of the transactions contemplated thereby.


