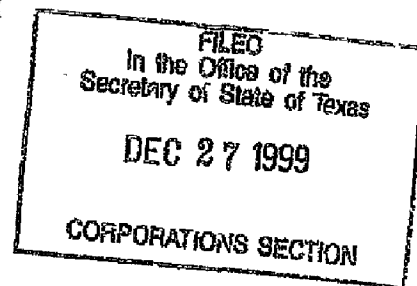

ARTICLE I

The name, state of organization and type of entity involved in the conversion is as follows:

ARTICLE II

ARTICLE III

ARTICLE IV

A copy of the Plan will be furnished by the Converting Entity (prior to conversion) or the Converted Entity (after the Conversion), upon written request and without cost, to any shareholder of the Converting Entity or the Converted Entity.

ARTICLE V

The Converting Entity has a total of 1,000 shares outstanding, all of which vote together as a single class.

ARTICLE VI

With respect to the Plan, the shares outstanding of the Converting Entity were voted as follows:
