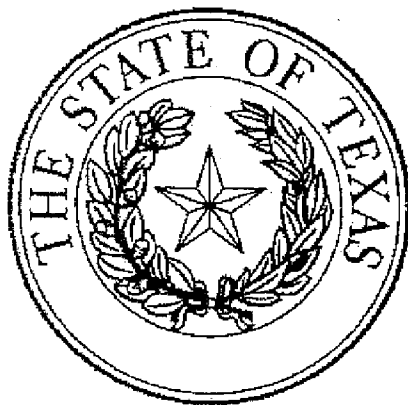

TO THE ARTICLES OF INCORPORATION
OF THE TELESIS GROUP, INC.**

Pursuant to Article 4.04 of the Texas Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

ARTICLE ONE

The name of the Corporation is THE TELESIS GROUP, INC.

ARTICLE TWO

The following amendment to the Articles of Incorporation was adopted by the shareholders of the corporation on the 2nd day of March, 1999.

The amendment alters Article I of the Articles of Incorporation to read as follows:

"The name of this corporation is PhotoTelesis Corporation."

ARTICLE THREE

In accordance with Article 9.10 of the Texas Business Corporation Act, the foregoing amendment was adopted by the unanimous written consent of the shareholders of the corporation, and any written notice required by Article 9.10 has been given.

The number of shares of the corporation outstanding at the time of such adoption was 1,000; and the number of shares entitled to vote thereon was 1,000.
