ARTICLES OF AMENDMENT TO THE
ARTICLES OF INCORPORATION
OF
PHOTOTELESIS CORPORATION

Pursuant to the provisions of Article 4.04 of the Texas Business Corporation Act, PhotoTelesis Corporation (the "Corporation") hereby adopts Articles of Amendment to the Articles of Incorporation which amend the Articles of Incorporation and all amendments thereto that are in effect to date as hereafter set forth and which contain no other change in any provision thereof.

ARTICLE ONE

The name of the Corporation is PhotoTelesis Corporation.

ARTICLE TWO

This amendment changes the Articles of Incorporation to change the article that names the Corporation. The article in the Articles of Incorporation is amended to read as follows:

ARTICLE ONE

The date of the adoption of the amendment by the shareholders of the Corporation is November 16, 2005.

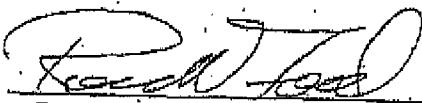
ARTICLE FOUR
