
FULL RELEASE OF SECURITY AGREEMENT

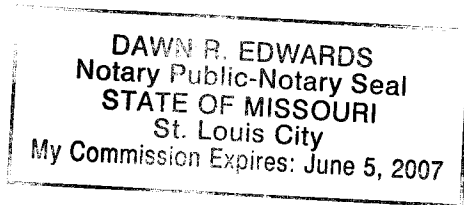
