TRADEMARK ASSIGNMENT

WHEREAS, LSF IV LOTO, L.L.C., a limited liability company organized under the laws of Delaware, having a principal place of business at 717 N. Assignor hereby sells, assigns, transfers and sets over unto Assignee all of Assignor's right, title and interest, anywhere in the world, in and to the Mark and the registration therefor, together with the goodwill of the business in connection with which the Mark is used and that part of the goodwill of the business connected with the use of and symbolized by the Mark;
2. Assignor further covenants and agrees that it will, at any time upon request, execute and deliver any and all documents that may be necessary or desirable to perfect Assignee's rights in and to the Mark; and
3. This Assignment includes any and all rights to, use for and recovery of all damages for infringement of the Marks, past and future, and the causes of action therefor. Further, Assignor agrees to cooperate in any such actions to the extent reasonably required by Assignee to enforce the rights transferred hereunder.
