Box 498, Brattleboro, Vermont 05302 (the "Assignor"), and FiberMark North America, Inc., a corporation organized and existing under the laws of Delaware, located at 161 Wellington Road, P.O. Box 498, Brattleboro, Vermont 05302 ("Assignee").

WHEREAS, Assignor wishes to assign, transfer, convey and deliver to Assignee, and Assignee wishes to acquire from Assignor, all of Assignor's right, title and interest in and to all U.S. and foreign (a) trademarks, service marks, trade names, service names, brand names, trade dress rights, logos, Internet domain names and corporate names and general intangibles of like nature, including those which are subject of registrations and applications for registration which are listed on Appendix 1 attached hereto and incorporated herein by reference, in each case, together with the goodwill of the business associated therewith, (collectively, the "Trademarks"), (b) patents and applications therefor, including continuations, divisionals, continuations-in-part, or reissues of patent applications and patents issuing thereon, including those patents and patent applications which are listed on Appendix 2 attached hereto and incorporated herein by reference (collectively, the "Patents"), (c) copyrights and registrations and applications therefor and copyrightable works of authorship, and mask work rights, including those which are subject of registrations and applications for registration which are listed on Appendix 3 attached hereto and incorporated herein by reference (collectively, the "Copyrights"), and (d) all other similar intellectual property including proprietary information, trade secrets, know-how, inventions, processes, designs and specifications, (the "Other IP"), in each case, owned by Assignor.

NOW, THEREFORE, in consideration of the sum of one dollar (\$1.00) paid by the Assignee to the Assignor and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

Assignor does hereby assign, transfer, convey and deliver to Assignee and Assignee does hereby acquire and accept all of Assignor's right, title and interest in and to the Trademarks, Patents, Copyrights and Other IP, together with the whole of the goodwill of the business associated with the Trademarks, throughout the world, to be held and enjoyed by Assignee for its own use and enjoyment, and for the use and enjoyment of its successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this assignment would not have been made, together with all rights to sue, counterclaim, and to collect damages and payments for claims of past, present, and future infringements, unfair competition or misappropriations or other violations thereof, any rights to protection of interest in the Trademarks, Patents, Copyrights and Other IP and all income, royalties, damages and payments now or hereafter due or payable with respect thereto, for its own use and benefit and for the use and on behalf of its successors, assigns or other legal representatives.

Assignor authorizes and requests the Commissioner of Patents and Trademarks (and, with respect to any equivalent foreign rights, any other appropriate foreign or international office or registrar) to record Assignee as owner of the Trademarks, Patents, Copyrights and Other IP, as assignee of the entire right, title and interest in, to and under the same, for the sole use and enjoyment of Assignee, its successors, assigns or other legal representatives.

Assignor shall, from time to time, at the request of Assignee, and without further expense to Assignee, execute and deliver such other instruments of conveyance and transfer (including powers of attorney) as Assignee may reasonably request, in order to more effectively consummate the transactions contemplated hereby and to vest in Assignee good and marketable title to the Trademarks, Patents, Copyrights and Other IP, including, but not limited to, executing all documents necessary to record in the name of Assignee the assignment of any of the Trademarks, Patents, Copyrights and Other IP with the United States Patent and Trademark Office and, with respect to any equivalent foreign rights, with any other appropriate foreign or international office or registrar.

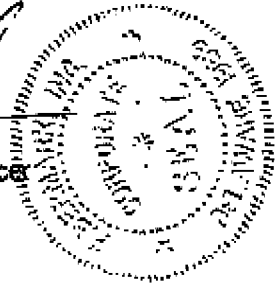

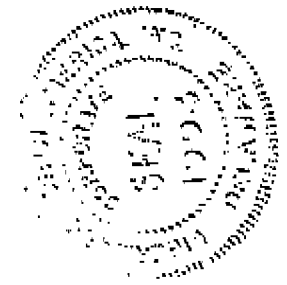
