## TRADEMARK ASSIGNMENT

THIS ASSIGNMENT ("Assignment") is made effective as of June 1, 2005 from King International, Inc., an Ohio corporation ("ASSIGNOR"), to SABA Chemical, Corp., a New York corporation ("ASSIGNEE").

WHEREAS, ASSIGNOR is the owner of the trademark "KING PINE," which is registered in the United States Patent and Trademark Office under Registration Number 1,574,209, dated January 2, 1990; and

WHEREAS, on or about June 1, 2005 ASSIGNOR and ASSIGNEE entered into an Agreement by which ASSIGNOR sold to ASSIGNEE the assets of ASSIGNOR'S manufacturing and production business of a line of cleaning products sold under the "KING PINE" trademark, including the "KING PINE" trademark; and

WHEREAS, in conformance with Agreement ASSIGNOR assigned to ASSIGNEE its interest in the "KING PINE" trademark; and

WHEREAS, ASSIGNOR desires to formalize and clarify and reaffirm the aforementioned assignment of the trademark.


NOW, THEREFORE, in consideration of the foregoing premises and for other valuable consideration, the receipt and sufficiency is hereby acknowledged, ASSIGNOR hereby conveys, transfers, assigns and delivers to ASSIGNEE all of ASSIGNOR'S right, title and interest of whatever kind in the trademark, along with the registration of the trademark and together with, but not limited, to the following:

1. The good will of the business relating to the products upon which the trademark is used and for which the trademark is registered;
2. All income, royalties and damages hereafter due to ASSIGNOR with respect to the trademark, including, without limitation, damages and payment for past, present and future infringement of the trademark; and
3. All rights to sue for past, present and future infringement or misappropriation of the trademark.

SUBJECT, HOWEVER, to the prior limited rights to the use of the trademark of Louis Garraton, Inc., a Puerto Rico corporation, whose address is 869 Street C, Bapalmas Catano, Puerto Rico 00962 ("GARRATON"), which GARRATON acquired through the "Conditional Assignment of Trademark Rights to a Specific Area," dated October 19, 2001, and currently recorded in the United States Patent and Trademark Office at Reel/Frame 3244/0823 as a "Conditional Assignment."
