ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
CHARAH ENVIRONMENTAL, INC.

Pursuant to the provisions of KRS 271B.10-030 and KRS 271B.10-060, the following Articles of Amendment to the Articles of Incorporation of CHARAH ENVIRONMENTAL, INC., a Kentucky corporation, ("Corporation") are hereby adopted:

1. The name of the Corporation is CHARAH ENVIRONMENTAL, INC.
2. Article I of the Corporation's Articles of Incorporation is hereby amended in its entirety to read as follows:

The name of the Corporation is: CHARAH, INC.

3. This Amendment was adopted by the Corporation's Board of Directors by unanimous consent dated and effective May 17, 2004 and submitted for approval by the Corporation's voting shareholders who approved the amendment by unanimous written consent dated and effective May 17, 2004.
4. The Corporation has outstanding 143,112 shares of Common Stock, having a par value of \$1.00 per share, each of which was entitled to one vote with respect to the amendment. All votes were cast in favor of the amendment, which was sufficient for approval of the amendment.

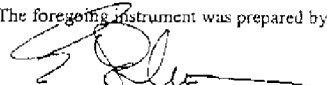
