## ASSIGNMENT

This ASSIGNMENT from JENNIFER LOPEZ, an individual (“Assignor”), to JLO HOLDING COMPANY, LLC, a limited liability company organized and existing under the laws of the State of Delaware (“Assignee”), is entered into and effective as of the date first written below.

### WITNESSETH

WHEREAS, Assignor owns all right, title and interest in and to United States Trademark Registration No. 2,946,847 for the trademark JENNIFER LOPEZ, for “fragrances, namely, perfumery, fragrances for personal use, cologne, perfume and eau de toilette; skin preparations namely, skin cream, body cream, hand cream, skin lotion, body lotions, skin moisturizers, skin emollient, skin cleansing creams, skin cleansing lotions, toilet soaps,” and “jewelry and watches” (the “Registration”), including the goodwill corresponding thereto.

WHEREAS, Assignee desires to acquire from Assignor, and Assignor now wishes to assign to Assignee, any and all of Assignor’s right, title and interest in and to the Registration, including the goodwill of the business in connection with which the mark is used and which is symbolized by the mark, together with the right to recover for any past, present and future infringements and violations thereof;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby sells, assigns, transfers and conveys to Assignee, its entire right, title and interest in and to the Registration, together with the goodwill of the business in connection with which the mark is used and which is symbolized by

the mark, together with the right to recover for any past, present and future infringements and violations thereof.

Further, Assignor agrees that, upon request and without further compensation, but at no expense to Assignor, it and its legal representatives and assigns shall undertake all reasonable and lawful acts, including the execution of documents and the giving of testimony, that may be necessary or desirable for maintaining, renewing or enforcing the Registration.


Assignor represents and warrants that it has authority to enter into this Assignment and has not granted and will not grant to others any rights inconsistent with the rights granted herein.
