RELEASE OF SECURITY INTEREST

WHEREAS, Lender, in recognition of Premium Plastic's satisfaction of the Security Agreement, desires to acknowledge the release and discharge of its security interest in the Marks.

NOW, THEREFORE, in consideration of the above forgoing representations, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby:

1. Lender hereby releases and remits to Medegen Medical any and all right, title and interest in and to the Marks; and

2. Lender hereby authorizes Medegen Medical or Medegen Medical's authorized representative to record this Release of Security Interest with the United States Patent and Trademark Office.
