**RELEASE OF SECURITY INTEREST IN TRADEMARKS**  
**(Vogt Power International Inc.)**

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of September 29, 2006 (this "Release"), is by PNC BANK, NATIONAL ASSOCIATION, in its capacity as agent for the Banks referred to below (in such capacity, the "Agent"), in favor of VOGT POWER INTERNATIONAL INC., a Delaware corporation (the "Grantor").

**RECITALS**

WHEREAS, the Grantor, its affiliates, certain lenders (the "Banks") and the Agent are parties to a Revolving Credit and Security Agreement, dated as of March 2, 2005 (the "Credit Agreement");

WHEREAS, as security for the obligations under the Credit Agreement, the Grantor granted to the Agent a lien and security interest in all of its assets, including its trademarks; and

WHEREAS, the obligations of the Grantor and its affiliates to the Agent and the Banks under the Credit Agreement have been repaid in full;

**RELEASE**

NOW THEREFORE, in consideration of the mutual agreements set forth herein, the Agent, on behalf of itself and the Banks, hereby releases and terminates its security interest and liens on all of the assets of the Grantor, including without limitation, the trademarks identified in Schedule 1 annexed hereto.
