RELEASE OF SECURITY INTEREST

This RELEASE OF SECURITY INTEREST is dated and effective as of the 14 day of July, 2006, and is made by The Royal Bank of Scotland plc as Agent (the *Grantee*), in favor of Four Seasons Sunrooms Acquisition Partnership (formerly known as Pizza Acquisition Partnership), a Delaware general partnership, Four Seasons I LLC (formerly known as Pizza Acquisition I LLC), a New York limited liability company, Four Seasons Sunrooms LLC (formerly known as Pizza Acquisition II LLC), a New York limited liability company, Four Seasons Solar Products LLC (formerly known as Pizza Acquisition III LLC), a New York limited liability company (collectively, the *Grantors*).

WITNESSETH:

WHEREAS, on or about July 13, 2001, Grantors granted to Grantee a lien on and security interest in, *inter alia*, various intangible assets, including without limitation trademarks, security marks, logos, indicia, trade names, corporate names, company names, business names, fictitious business names, trade styles or other source or business identifiers (collectively, the *Trademarks*), all pending applications therefor (the *Applications*), and all registrations issued thereon (the *Registrations*); and further including the goodwill of Grantors' business symbolized thereby and associated therewith; and

WHEREAS, the aforementioned security interest was reflected in a duly executed document entitled "TRADEMARK SECURITY AGREEMENT"; and

WHEREAS, for good and valuable consideration, Grantee has agreed to release the aforementioned security interest.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:
