This assignment shall be binding upon and inure to the benefit of the parties and their successors and assigns.

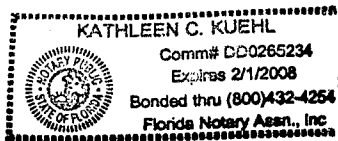
